1. Online access is provided to lessons, assignments and tests.
2. Online access to full solutions for tests and assignments. Currently tests and assignments are limited in number.
3. Online access will terminate after the chosen period from the date we enable access.

Terms and Conditions

This agreement is between 'you' (the student or parent/guardian) and 'us/we' (SCIMS Academy).

1. You must satisfy the admission criterion mentioned in 'Academic details'. If the criterion is not met, or we feel that the admission request is not genuine, we have the right to refuse admission without assigning any reason.
